

## IMPORTANT AND URGENT! UPDATE OF THE PPK REGULATIONS



Dear Sir or Madame,

please be informed that PKO TFI has updated:

- the Regulations for the use of the iPPK Application, available [here](#)

**The revised regulations will take effect tomorrow, i.e., 15/09/2023.**

**The changes made relate to blocking the ability to log into the iPPK Application from the Internet Explorer browser.** The decision is based on the fact that the Internet Explorer browser is no longer supported by the manufacturer, Microsoft, and is not being updated. This affects the functional performance of this browser, speed of operation and security issues.

As a result, and most importantly for security reasons, **the iPPK Application also no longer supports this browser.** This means that you will no longer be able to log into the iPPK Application from the Internet Explorer browser.

**We kindly ask you to use other browsers such as Google Chrome, Mozilla Firefox or Microsoft Edge when logging into the iPPK Application.**
